## **Purpose and Process of Personal Data**

Breakout Rotterdam processes information for the following purposes:

Information supplied to us, is only used on the basis of legitimate interest

- If necessary, you can contact us via telephone or email for the carrying out our services
- Breakout Rotterdam can Inform you about changes to our services and products

## **Sharing Personal Data with Third Parties**

Breakout Rotterdam will not sell your information to any third party and will only provide it if this is necessary for the execution of our agreement with you. With companies that process your data in our assignment, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Breakout Rotterdam remains responsible for these processing operations.

## **Cookies**

Breakout Rotterdam uses functional, analytical and tracking cookies. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit our website. The functional cookies that we use are necessary for the technical operation of our website and your ease of use. They ensure that the

website works properly and remember, for example, your preferences. This process also helps to optimize our website. You can opt out of cookies by setting your internet browser to not store cookies. In addition, you can also delete all information previously saved via your browser settings.

The analytical cookies that we collect are cookies that are placed to measure and analyse the traffic behaviour on our website. We use this information to make the website as optimal and user-friendly as possible.

By means of the tracking cookies, we can analyse your surfing behaviour within our website. With these cookies we keep track of the pages you visit so that we can draw up a profile of your online behaviour. This profile is not linked to your name, address, email address, etc., but only serves to match advertisements matching your profile.

## **View, Modify or Delete Data**

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data used by Breakout Rotterdam. You have the right to data portability. This means that you can submit a request to us to send the personal information we have from you in a computer file, to you, or, another organisation confirmed by you.
